The Holiday Inn Airport in Des Moines served as the host facility of the Association of Iowa Fairs 2024 Conference and Annual Meeting. The Conference was held on December 13 to 15. Representatives from the 106 fairs in Iowa and of the 134 associate members converged onto the Conference Center for a weekend of learning, sharing and fun.

As in past Conferences this year's event enjoyed strong involvement with final attendance for the Conference had 1,156 people registered for the event and again saw higher than normal meal reservations.

The Conference got underway on Friday morning with the opening business meeting of the Association, followed by several workshops and idea-sharing discussions.

The 'Honky-Tonk Happy Hour' was held Friday late afternoon prior to the Awards Banquet. Three AIF associate members who hosted this fun event included Grandstand Concerts, Spectrum Weather Insurance and Thunder & Lightning Productions.

The annual Awards Banquet was held Friday evening for members of the Association. Honors presented at the Banquet included the "Fairman of the Year", the "Leo Overland Memorial Showman of the Year" and recognizing the Fairs that received the AIF's "Blue Ribbon Fair" award for 2024. In addition, the 2024 Hall of Fame inductees and recipients of the AIF's scholarship were also recognized at the Awards Banquet.

After the Awards Banquet Friday evening the popular live entertainment showcase was held. In addition, a reception was held for Jo Reynolds, immediate past Chair of the IAFE Board of Directors, and retiring Iowa State Fair Board members Gary McConnell and Gary VanAernam.

The Saturday morning keynote address featured Sara Kunz, an award-winning entrepreneur, 2x Discovery Channel Primitive Survivalist, and Trauma Survivor. Sara's moving personal story is about overcoming physical, mental, and emotional setbacks on her road to success. In her keynote, 'Joyful Resilience', Sara shared her life experiences and challenges, and how she was able to turn these into valuable learning lessons to promote a better life. She spoke to the struggles we all face in life, how to build the grit and grace needed to come through the other side. As in past Conferences, the keynote address was a Conference highlight presented to a standing room only crowd.

Sunday morning started out with a church service dedicated to deceased fair board members and fair volunteers in Iowa, followed by the popular "Fairman's Breakfast". The Sunday morning speaker featured Courtney Hinds, CEO of the Wyoming State Fair. Her presentation focused on the basics (and the importance) of developing a succession plan for fair board members and other key personnel. Courtney's address to the capacity crowd proved to be a great way to end the 2024 Conference.

Business meetings held during the Conference included the Association's Annual Meeting, the Iowa State Agricultural Society Annual Meeting, Carnival Owners' meeting, Iowa Horse Racing Association meeting, Iowa Foundation for Agriculture Advancement meeting and AIF Associate Members' meeting.

IAFE Consumer Protection Program Workshop Held

The AIF Board contracted with IAFE to offer its CPP Workshop to all member AIF fairs. The workshop was on Thursday of the Conference. Dr. Stephen Neel of Technical Solutions International, developed the Consumer Protection Program



workshop to help fairs understand enteric pathogens such as E. Coli and to provide information for risk management including identifying traffic flow in all animal areas (not just petting zoos), creating proper signage, installing hand-wash areas and other intervention or avoidance tactics.

Sixty-eight fair board members attended the 6-hour workshop.

FROM THE OFFICE ...


