## ***About the Association of Iowa Fairs***

The Association of Iowa Fairs (AIF) is a voluntary, non-profit corporation formed in 1907 with the intent of organizing the state, district, and county agricultural fairs of Iowa, festivals, associations, industry related businesses and individuals into one association that would focus on the improvement of fairs and related interests in Iowa. Throughout the years, the AIF has held steadfast to its purpose of promoting and encouraging the development and improvement of the fair industry in Iowa, while focusing on the education of the youth of Iowa, and showcasing Iowa's agricultural, industrial and domestic heritage.

The AIF membership includes the 105 Iowa County/District Fairs and the Iowa State Fair. In addition approximately 150 Associate Members are members of the AIF. These Associate Members include local festivals and chambers, artists and attractions, carnivals, agents, concessionaires and other businesses related to the fair industry.

The AIF functions through a Board of Directors that consists of 12 District Directors, two from each of the six fair districts in Iowa. Member Fairs from each district elect their respective AIF District Directors at the Fall District Meetings. Directors are limited to serving 6 two-year consecutive terms on the Board. Officers of the Board are made up from members of the Board and include the President, First Vice President and Second Vice President. Officers serve a one-year term in their respective position and are elected to these positions by members of the Board. The AIF Board appoints its Executive Director and Executive Secretary/Treasurer. Both of these positions are non-voting positions. The Executive Committee of the Board is made up of the most immediate Past President, current President, First Vice President, Second Vice President, Executive Director and Executive Secretary/Treasurer.

The AIF hosts two district meetings in each of the six fair districts each year, one in the spring and one in the fall. In addition to the district meetings, the AIF's Conference and Annual Meeting is held in December. At this Conference, all AIF members gather for 3 days of educational workshops and seminars, interaction between fair members and associates for the purpose of booking entertainment and purchasing fair related supplies and social events including an awards banquet, benefit auction and spouses' activities to name a few. Iowa State Fair Board Directors are elected at this Conference by member Fairs.

The AIF awards two \$1000 scholarships each year, one to a qualifying FFA member and one to a qualifying 4-H member, who are graduating high school seniors and are planning post-high school education. The applicant's field of higher education must be tied to agriculture. Some examples include ag-business, veterinary medicine, livestock production and agronomy. The scholarship funds must be spent for tuition or fees at a two or four year college, with preference given to Iowa schools.

The AIF maintains a current listing of all members and regularly provides its members will information pertinent to the membership and maintains a website that is accessible to all persons interested in the AIF and its members. The AIF also is active in legislative efforts in Iowa, spending much time lobbying for legislation that will benefit all members of the AIF. The AIF employs a registered lobbyist to work with elected officials and the Governor's office throughout the year on all issues relating to the AIF and its membership.

The AIF maintains an active membership with, and participates in events sponsored by, the International Association of Fairs and Expositions (I.A.F.E.), Outdoor Amusement Business Association (O.A.B.A.), and National Independent Concessionaires Association (N.I.C.A.).

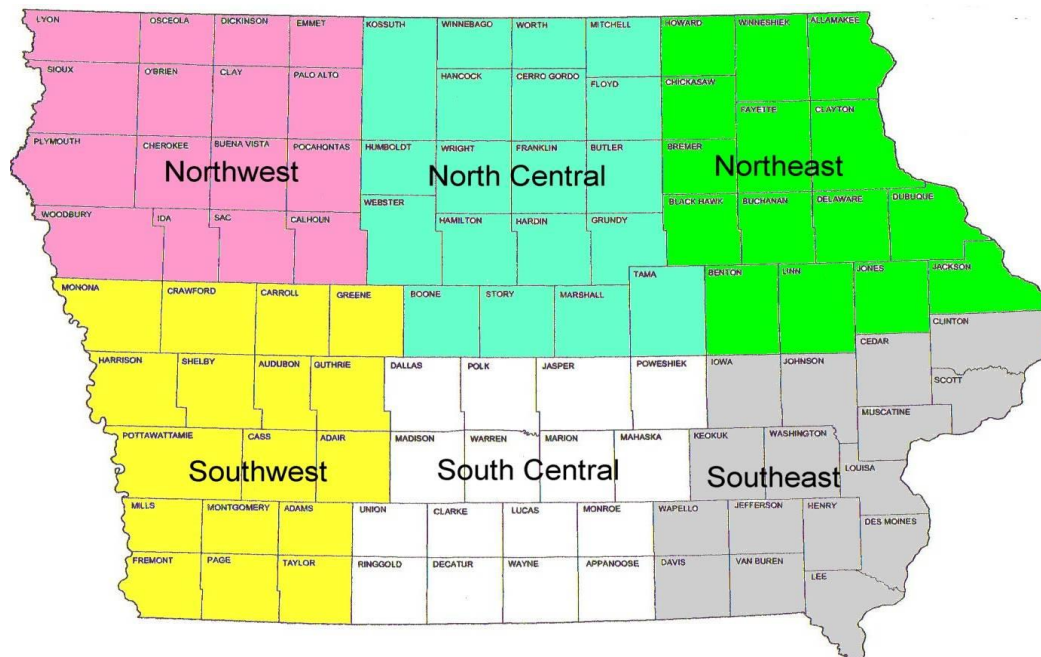

**Northwest District:** Includes the counties of Buena Vista, Calhoun, Cherokee, Clay, Dickinson, Emmet, Ida, Lyon, O’Brien, Osceola, Palo Alto, Plymouth, Pocahontas, Sac, Sioux, and Woodbury.

**North Central District:** Includes the counties of Boone, Butler, Cerro Gordo, Floyd, Franklin, Grundy, Hamilton, Hancock, Hardin, Humboldt, Kossuth, Marshall, Mitchell, Story, Tama, Webster, Winnebago, Worth and Wright.

**Northeast District:** Includes the counties of Allamakee, Benton, Blackhawk, Bremer, Buchanan, Chickasaw, Clayton, Delaware, Dubuque, Fayette, Howard, Jackson, Jones, Linn and Winneshiek.

**Southwest District:** Includes the counties of Adair, Adams, Audubon, Carroll, Cass, Crawford, Fremont, Greene, Guthrie, Harrison, Mills, Monona, Montgomery, Page, Pottawattamie, Shelby and Taylor.

A Fair is an exhibition of three days or more in duration that is held annually in the State of Iowa and is conducted by a registered non-profit Association in the State of Iowa that is formed for the purpose of conducting a Fair. The Fair is to promote industry, commerce, agriculture, horticulture, 4-H, FFA, or other youth organizations by offering prizes, premiums, reward, scholarships, or recognition for outstanding exhibits or participation.

A member Fair of the AIF must comply with Iowa Code, Chapter 174, and with other membership and organizational regulations as set forth by the Board of Directors of the AIF. Each member Fair shall pay a membership fee to the AIF at a time and manner as set by the Board. The AIF is not legally required to accept all fairs that meet the Iowa Code chapter 174 definition into the Association. The Association has no requirement for membership based on code definition alone.

Each member Fair shall have one vote in all affairs brought forward at the district meetings and annual meeting of the AIF. The person representing a member Fair at any AIF meeting must be on the Board of Directors of the member Fair.
