The Association of Iowa Fairs enjoyed another great turnout for its 2011 Conference and Annual Meeting held on December 9 - 11, at the Holiday Inn Airport in Des Moines. Representatives from the 106 fairs in Iowa, plus representatives of the 150 plus associate members converged onto the Conference Center for a weekend of learning, sharing and fun. Final attendance tally for the Conference showed just over 1,400 people registered for the event.

The opening business meeting of the Association was held on Friday morning, followed by the very popular session *"Open Forum"*. The ever-popular entertainment showcase was featured Friday afternoon.

Workshops that were featured Friday afternoon included; *"Marketing Basics"*, presented by Lori Chappell, Marketing Director of the Iowa State Fair; *"Property Insurance, Is Your Fairgrounds Covered?"*, presented by Amy Hatten-Blaskovich (Underwriting Coordinator) and Megan Roth (Communications Coordinator), Iowa Communities Assurance Pool; and *"Who We Are, What We Do"*, moderated by AIF Directors.

The annual Awards Banquet was held Friday evening, followed by a reception for all AIF member Fairs hosted by ICAP.

The Saturday schedule was packed with workshops, a breakfast meeting for A.I.F associate members and a non-stage showcase highlighting associate members that specialize in grounds attractions, suppliers and other non-music type of entertainment. Saturday opened with Gary Berg's keynote address, *"Simple Truths"*, proved to be one of the highlights of Conference, as evidenced by the enthusiastic response from a full room of attendees.



#### **Conference Meetings Held**

Business meetings held during the Conference included the Association's Annual Meeting, the Iowa State Agricultural Society Annual Meeting, Carnival members' meeting, Iowa Horse Racing Association meeting, Iowa Foundation for Agriculture Advancement meeting and A.I.F. Associate Member Breakfast & Business Meeting. Saturday workshops and seminars included "2012 Fair Ideas" hosted by Arlette Hollister; "Failing to Plan is Planning to Fail, Part II" presented by Jim Lester, Wright County Emergency Management Coordinator and Tricia Rosendahl, Manager, Wright County Fair; "F.S.Q.A. Training for Livestock Exhibitors" presented by Mike Anderson, I.S.U. Extension Youth Campus Director, Livestock Specialist; "VIP Program for Your Fair" presented by Deb & Louie Zumbach, Linn County Fair; "Tracking Fair Entries" presented by Deb Brown & Haley Hansen, Franklin County, and Sue Barnes, Howard County; "Concessions and Fairs, a Partnership" presented by Kevin McGrath, owner of The Best Around Concessions. One of the Saturday workshops, "Rookie Status", featured a discussion on IAFE's 'Young Professionals Initiative' moderated by Jenn Dunn, Linn County Fair.

Saturday evening featured the very popular "Social A'Fair and Auction". This included a social and supper attended by over 600 Association members. The auction had 143 items donated from member fairs and associates. The proceeds from the auction are used for expenses that are incurred by the Association in its efforts to secure legislation that benefits the fair industry in Iowa. This year the auction raised just over \$28,000. Following the Social and Auction was the "President's Reception", hosted by 2011 A.I.F Board President Darwin Gaudian and his wife Jan, and members of the O'Brien County Fair Board.

Sunday morning started out with a church service dedicated to deceased fair board members in Iowa followed by the popular "Fairman's Breakfast".

Four 'sharing workshops' were held on Saturday & Sunday. These sessions featured a panel of persons with expertise in the topic subject. These panelists gave a brief overview of their opinions on the topic with the bulk of the session being an open discussion by those in attendance.

- "Race Tracks and Motorsports Events" with panelists Tim Holt, Hamilton County, Denny Bell, Buchanan County and Shawn Van Engelenhoven, Mahaska County
- *"The ABCs of a Fair Board"* was an interactive discussion on the operation and purpose of a county fair board. Discussion points were methods of operation, committee structure, board member responsibilities and ethics. This workshop was moderated by the A.I.F Board Executive Committee
- "Livestock Shows What is the Future?" where discussion items included State of Iowa regulations proper animal presentations and showing, new treads in livestock production, responsibilities of a county fair and ethical practices by exhibitors and families. Panelists for this workshop were Clint McDonald ISU Extension Beef Program Specialist and Mike Anderson, I.S.U. Extension Youth Campus Director, Livestock Specialist
- "Short Takes" which was an open discussion on unique events or activities Fairs have that increase attendance. Areas of discussion included special themed days, targeting specific age groups, contests and ticket promotions, to name a few. This workshop was hosted by A.I.F. Board members.
